### Privacy Policy

This Privacy Policy describes the types of information collected by **Paul Anwandter** on this website and how we use and protect.

This Privacy Policy applies only to this website and does not apply to banners, contests, announcements or promotions, that have our sponsorship or participation in our website or third party websites.

Your consent to this Privacy Policy

By using our website you signify your acceptance of this Privacy Policy and agree that the **Paul Anwandter** make use of any personal information that you provide or submit to this website is governed by its terms and conditions.

If you do not accept the terms of this Privacy Policy, please do not use this website or disclose your personal information.

#### Information we collect

The term "Personal Information" as used in this Privacy Policy, means information that identifies you personally, such as your name, address, telephone number, age and / or email.

The web page that you entered may collect information through contests, questions, contests, surveys, subscriptions, questionnaires promotion or registration forms. Some of our sites may require registration forms to enable it to participate in contests, games or other activities.

#### How we use Personal Information

#### Collection and use of other information: Use cookies

With whom we may share information

Users guarantee and respond, in any case, the veracity, accuracy, validity and authenticity of the personal information provided, and undertake to keep them updated.
